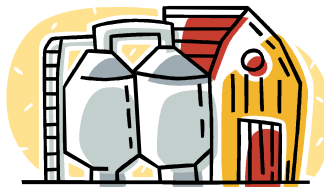

#### RELEASE & CONSENT TO PROVIDE MEDICAL CARE

I understand that: (1) The purpose of the Farm Safety Day Camp is to educate children about the safe use of equipment. One of the methods used for education will be actual demonstrations involving the participants. All activities will be closely supervised by camp counselors and instructors. However, due to the dangerous nature of the machinery, there is possibility of accidents. I agree to hold the counselors, instructors, and sponsors harmless in the event of injury to my child so long as due care has been exercised by these parties. (2) First aid will be available at camp; the campers will be supervised and if a serious illness or injury develops, medical and/or hospital care will be provided. I further understand that, in case of serious injury or illness, I will be notified. If it is impossible to contact me, I give permission for emergency treatment or surgery as recommended by the attending physician.
